Proposed HIV Measure Set for 2020

- At the October 2018 VBP Workgroup meeting the committee approved 40 Category 1 and 2 quality measures (including both P4P and P4R Category 1 measures) for the 2019 HIV Quality Measure Set.
- The following recommended changes to the HIV VBP Quality Measure Set for 2020 are based on the feedback received by the DOH from the Clinical Advisory Groups, Measure Feasibility Task Force and Subteams, and proposed VBP Roadmap updates.

Remove from Measure Set	Removed / Removed and replaced with another measure	3
Add to Measure Set	New measures added	2
Category Change (Cat 2 to Cat 1)	Moved from Cat 2 to Cat 1	1



Sexually Transmitted Infections: Screening for Chlamydia, Gonorrhea, and Syphilis

- Denominator: HIV positive patients 13 years of age or older
- Three separate numerators:
 - * Patients who had one or more Syphilis Screening Performed during measurement year
 - Patients who had one of more tests for Chlamydia during the measurement year: urine/cervical/urethral, pharyngeal, AND rectal
 - Patients who had one of more tests for Gonorrhea during the measurement year: urine/cervical/urethral, pharyngeal, AND rectal



STI Screening Measure Gonorrhea and Chlamydia



* Genital screening includes "urine, urethral, vaginal, or cervical" screens
